Last Will and Testament

THIS WILL is made by me XXXXXX of XXXXXXXXXX

1. Revocation

1.1. I revoke all earlier Wills and testamentary dispositions.

2. Appointment of Executors

2.1. I appoint my wife XXXXXXXXX to be my executrix and Trustee but if she is unable or unwilling to act or if she dies before proving my Will I make the following appointment instead.

2.2. I appoint XXXXXXXXX of XXXXXXXXXXXXX and XXXXXXXXX of XXXXXXXXXXXXXXXXX as my substitute Executors and Trustees.

2.3. The expression "my Trustees" means my personal representatives and the Trustees of this Will and of any trust that might arise under it where a further appointment of trustees has not been made.

3. Appointment of guardians

3.1. If my wife XXXXXXXXX shall predecease me I appoint XXXXXXXXXXXXXXXXX of XXXXXXXXX to be the guardian of my children during their respective minorities and in the event of XXXXXXXXXXXXXXXXX predeceasing me or being unwilling or unable to act at any time during the minority of my children I appoint XXXXXXXXX to act in the place of XXXXXXXXX.

4. Provision for Pets

4.1. If my wife XXXXXXXXXXXXXXXXX shall predecease me it is my wish and desire that any pets in my possession at the date of my death shall be provided with a good home for the remainder of their natural lives and to this end, I give my pets to XXXXXXXXXXXXX of XXXXXXXXX on the understanding that XXXXXXXXX will honour my wishes concerning the welfare of my pets.

5. Definition of My Estate

In my Will where the context so admits "my Estate" shall mean:

- 5.1. All my property of every kind wherever situate.
- 5.2. All my property of every kind wherever situate over which I have a general power of appointment.
- 5.3. The money investments and property from time to time representing all such property.

6. Administration of My Estate

My Trustees shall hold the residue of my Estate upon trust to retain postpone or sell it and will:

- 6.1. Pay any debts funeral and testamentary expenses.
- 6.2. Satisfy all gifts of specified property referred to in my Will.
- 6.3. Pay all the gifts of money referred to in my Will.
- 6.4. Deal with the remainder ("my Residuary Estate") as I now direct.

7. Gift of Residue

I give my Residuary Estate to my wife **XXXXXXXXXXXX** subject to her surviving me but if this gift fails then the following provisions shall apply instead.

8. Further Gifts of Residue

Subject as above my Trustees shall give the residue of my estate to my daughter **XXXXXXX** and my son **XXXXXXXXXX** subject to each attaining 25 years of age and until such attainment the income thereof shall be accumulated or applied wholly or in part by my Trustees in their absolute discretion from time to time for such beneficiary's maintenance education or benefit as shall survive me and if more than one in equal shares and if either of them shall fail to obtain a vested interest leaving issue who survive me and reach the age of 25 years then such issue shall take by substitution such failed share and if there shall be more than one of such issue they shall take in equal shares per stirpes but so that no issue shall take whose parent is alive and so capable of taking.

9. Standard Provisions

The Standard Provisions of the Society of Trust and Estate Practitioners (2nd Edition) shall apply.
